1. On Public Comment or Citizens Communication, County Judge gave an update on the renovation repairs at the Civic Centers and gave anticipated completion dates. He also informed on the new tractor/shredder bought for the Landfill. Sally Lichtenberger announced that the COG containers will be in place for the disposal of used tires.
2. On a motion made by Comm. Perez and seconded by Comm. Vera that we approve the minutes of the Regular Commissioner's Court Meeting of May 2023. Motion carried with all member voting "Aye" and Against "None".
3. On a motion made by Comm. Perez and seconded by Comm. Garza that we approve payment of bills. Motion carried with all members voting "Aye and Against "None".
4. On a motion made by Comm. Guerra and seconded by Comm. Vera that we approve the Department reports. Motion carried with all members voting "Aye" and Against "None".

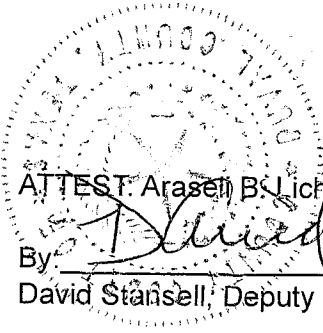
