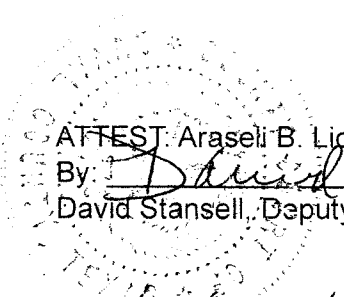
Judge Cantu wanted to congratulate all the candidates that ran in the election, he said it took a lot of courage to run and reminded us we are here for the people and to move forward.
