4. Adjournment

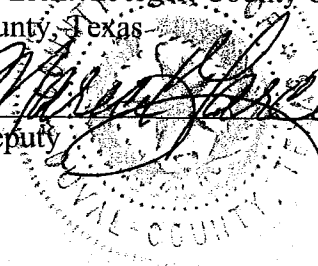
